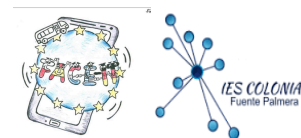

## ERASMUS STUDENTS' REQUIREMENTS. FACE IT RULES.

1. ALL Students must follow and respect our FACE\_IT rules to respect different laws of all countries.
2. All travelling students must host an international student during their country host week.
3. Host Families must provide a single bedroom if the international student has a different gender from their child's.
4. Host families should pick their host student up from school when necessary.
5. Host families must provide activities to do with the international student in their free time.
6. Host families must call their national coordinator to solve any relevant issues during the host week.
7. Travelling students must respect the travelling airline rules dealing with luggage weight, luggage measurement, liquids etc. Liquids must be placed in a square transparent plastic bag. This bag must be taken out of the suitcase. Laptops and iPads as well as watches and metallic objects, must too be taken out of the suitcase at the airport.
8. Travelling students must wear their Face it ID badge.
9. Having breakfast, lunch and dinner every day is compulsory. Breakfasts and dinners will be at home with the host family, they will provide packed lunch including a sandwich, ½ bottle of water, a piece of fruit and something sweet. Extra food or soft drink will be paid by students.
10. ALL Students must respect all our foreign teachers as their own teachers.
11. Alcohol and any other drugs are forbidden for all students in this project, at home or abroad.
12. No chewing gum is allowed during lessons. Mobile phones must be switched off at schools, except if they are asked to use them by a teacher.
13. All programmed activities and excursions are compulsory.

14. Shouting or running in corridors or stairs is not allowed.
15. Students are responsible to know the roaming policy of their mobile company.
16. The official language of this project is English, we must avoid talking in our mother tongue in the presence of other international students, it may be considered rude.
17. All participant students will have compulsory assignments to do before, during and after their mobility.
18. Students and/or hosting students must report to their teachers any problem they have at home, at school or on the trips.
19. ALL students must follow the country law, the school law and our Face\_it rules. If a student commits a crime or misbehaves and has had to be expelled from the school or from the country, the student's parents must pay for the early return ticket.
20. All students must have all the required documents signed up to leave their country or to participate in the project:
  1. Updated passport.
  2. Updated ID.
  3. Updated European Health Card.
  4. Police office document (Greece: doesn't apply)
  5. Students' allergies, intolerances or health issues signed up by themselves and their families.
  6. Families permission to use school or project Facebook.
  7. Families permission to post pictures and/or be video recorded.
  9. Document of FACE IT equipment care and responsibility signed up.
  10. This document signed up.(All these documents and info will adjust to Data Protection Law)
