## Erasmus+ strategiska partnerskap skola

### Besked om beviljad ansökan

Universitets- och högskolerådet har nu fattat beslut om vilka ansökningar till Erasmus+ strategiska partnerskap skola, omgång 2015, som beviljats medel.

Er organisation har beviljats medel under förutsättning att alla partnerorganisationer som ingår i projektet blir validerade. Projektet startar 1 september 2015.

Varje ansökan har bedömts av två externa experter inom utbildningsområdet utifrån ett antal kvalitetskriterier. Er ansökan har fått 74 kvalitetspoäng av 100 möjliga. Nedan följer en sammanställning av bedömarnas kommentarer för er ansökan:

### Relevance of the project/strategy

**26(30)**

The project "Shaking the Habitual: Norm Critical Approaches to Gender in Early Childhood Education Settings" is most relevant to the objectives and priorities of the KA2 action. Described aims and objectives have great relevance in today's society. The needs analysis should be even further developed from the different participating countries and organisations perspective. The proposal is not particularly innovative in its settings, but nevertheless important for the participating organisations and will have a positive impact at all levels. The transnational dimension becomes obvious in the applicant's description of partner differences and similarities.

### Quality of the project design and implementation

**13(20)**

The activities of this process oriented project are described thoroughly and clearly. Most phases of the project have been well designed and are relevant in relation to the aims and objectives. One aspect that should be improved though, is a further development in the proposal of how the partnership cooperate in between the planned meetings. The methodology, including reoccurring meetings at the respective partner schools for seminars and discussions, suits the aims well. But how the different themes that will be covered by each partner during the transnational meetings will be decided, needs to be set in mutual understanding and cooperation by the partners. This in order to make a red thread in their work. How the different researchers/universities will be included in the project also need to be clarified in the proposal. The budget is value for money. There are no training/learning activities foreseen in the project.

#### **Quality of the project team and the cooperation arrangements 14,5(20)**

The project team is very experienced within the field of the action and has the necessary skills for success. There is an equal distribution of tasks and responsibilities. However, the university contacts mentioned in the application could be included more in the application, since they seem to be important to the project. How the research paper being produced by Ms Gry will be integrated in the project also needs further explanation. Coordination and the communication progress are well catered for. The consortium will communicate through e-Twinning, blog and chat.

#### **Impact and dissemination**

**20,5(30)**

Evaluation will be running throughout the project's lifetime, which is excellent. But how evaluation will be performed needs to be further developed in the proposal. The evaluation process of the impact should also have been more concrete. The tools that will be used to assess the outcomes should have been described in a more elaborate way. There is also a need of evaluating the parents and the children at the different pre-schools participating in the project, and not only the teachers.

Dissemination is described in relation to every partner, which is good. However, the dissemination process should be described more concretely, and not just in general terms. The impact will be significant at the participating pre-schools, but how the results will be further transferred locally and regionally needs to be taken into consideration by the partnership.

### **Overall comments to the applicant**

This project is about strengthening the work with equality and gender in pre-schools. The project is generally well set in its structures, but needs some further improvement particularly concerning dissemination and evaluation. The partnership would also be considerably strengthened if the associated universities, or at least one of them, became a partner within the project.

### **Beviljade medel**

Om ni vill få ert ärende omprövat ska ni inom 14 dagar från det att beskedet mottogs inkomma skriftligen med en begäran om omprövning. Begäran ska innehålla projektnummer och en beskrivning av vad ni vill få omprövat.
