**Commentary:**Activities throughout the implementation period are well planned and are appropriate to achieve the stated objectives are innovative and well designed. Mobilities, have an adequate number of participants and provided 6 students per country in the short-term exchanges of students and 2 teachers in joint training events for staff. The methodology on which it will work is well defined and quality by proposing the use of many digital tools for project-based learning. The proposal is cost efficient with an allocation of adequate resources to each activity. The project is based on the use of eTwinning and includes a good description of the use to be done, combining physical exchanges with virtual cooperation before, during and after project implementation. On the other hand, it is clearly explained how the proposed activities will contribute to achieving the objectives and benefit centers and participants in terms of development staff and with results of tangible and intangible aimed at improving digital and linguistic competence learning and openness to Europe, through the realization of Teaching and Projects ABP Units, proposing the creation of gamificados challenges, educational games, construction and robot recordings and Chroma Scratch, creating comics with programming, Augmented Reality and a dossier on professions. risk assessment prior to the implementation of activities is expected. As proposed improvements suggested that planning learning activities, education and training are not confused with transnational meetings for coordination and monitoring of the project, which in some sections of the application have been described for this purpose,

**Commentary:** Among the positive aspects of the proposal that highlights the quality of the composition of the partnership with centers that have extensive experience in introducing innovative methodologies, new technologies and CLIL methodology as a tool for improving language skills, which will take formation and complementary to each other. The distribution of tasks and responsibilities is clearly defined and, although inexperienced centers participating in the Erasmus + program, such as the

case of Slovenian and British, they are to be supported by more experienced partners like the Spanish center. Another positive aspect is the fact that the Spanish center has eTwinning seal center and demonstrating a thorough knowledge of the platform, It provides mentoring and training other less experienced partners to grow in the knowledge of it. coordination and communication mechanisms periodically anticipated and well planned online using cooperation through eTwinning and various digital tools. In addition, transnational meetings are planned for evaluation, planning and project management, taking advantage of the 3 sets training events for staff. As weaknesses detected that, despite having good planning of activities and that these widely contribute to the achievement of project objectives and achieve high impact on participants, the drafting of planning short-term exchanges of groups of students does not meet an agreed and coordinated planning by the whole partnership, but it is the individual contribution of each partner to the project, as evidence justifying C5 and C6 activities. The project would improve if mechanisms for conflict resolution or contingencies between partners throughout the implementation period is contemplasen and if there is a more balanced sharing of responsibilities between partners.

**Commentary:**This application successfully develops a proposal by five primary schools in Spain, Italy, Greece, Slovenia and the United Kingdom. Such centers have, in most cases, with pupils from disadvantaged environments. a high level of involvement of the school community and motivation for learning and improving cooperation with other countries is also perceived. They have similar experiences and expertise on issues related to new technologies and have strengths to share and to be supplemented. Analyzing the proposal is found that it is properly part of the priorities of action by proposing open education and innovative practices in the digital age as a major horizontal priority and two additional priorities, a horizontal as social inclusion, which is highly relevant and specific priority school education, promote a comprehensive approach to teaching and learning languages. So, for development activities successfully they combine in the centers involving teachers and students in primary education aged between 10 and 12 years, families and groups, over 24 months, with 3 joint activities short-term training for staff and five short-term exchanges of groups of pupils in each partner country. These mobilities have a significant international impact on the project, especially the student, that will achieve a high impact on the training of participants. Regarding the strengths of the proposal can be noted that the objectives address European policies and are linked to the priorities of the action, the distribution of tasks and responsibilities among all partners is balanced and shows the commitment and active contribution of organizations participants and brings a clear added value at European level. Regarding the work program proposed and budgeted activities are consistent with clear objectives and the use of innovative methodologies using numerous digital tools. It aims to develop skills and abilities that can facilitate inclusion in the workplace regarding the development of digital competence, improving the English language and openness to Europe as three major goals. All in all a project is well resolved and based on new methodologies that can have a big impact.
