Waste management in Europe

The EU promotes 3R (reduce-reuse-recycle):

- Prevention (non consuming)
- Re-use of products
- Recycling (including composting)
- Using waste to generate energy



So does Greece... although we have a long way to reach our goals.

Targets of EU

- Reuse and recycle household waste >55% until 2025
- Reduce landfilling <10% until 2035

Landfilling is almost non-existent in countries such as Belgium, Denmark, Sweden, Germany, Austria and Finland

Recycling in Greece


More than 40 percent of the waste placed in blue dumpsters designated for recyclable materials is estimated to end up in the country's landfills, according to 2016 data seen by Kathimerini(greek newspaper).







The landfill method is still the most widespread waste disposal method in many southeastern EU countries such as Greece.





Recycling is an efficient way to reduce waste especially urban waste Landfill is a bad way to get rid of our waste. It is very burdening for the environment

How does tourism affect the amount of waste?

The amount of waste in Greece is significantly increased due to tourism during summer period.

Usually waste from restaurants and hotels is not recycled

There are different cars for garbage collection



Recycling step by step

- Collection of waste from the blue bin
- Transportation to the recycle factory
- Emptying of the rubbish in the reception area
- Mechanical separation of materials



- Transformation of the rubbish in small cubes using pressure
- Sending of separated materials to Athens for recycling





Composting step by step

- Collection of organic products
- Taking them for fast composting
- Leaving them for 4 weeks in the compost vat
- Removal of glass, plastic or other materials that could destroy our compost
- Spreading of the compost outside in a sunny place 6-8 months
- Packaging in bags







